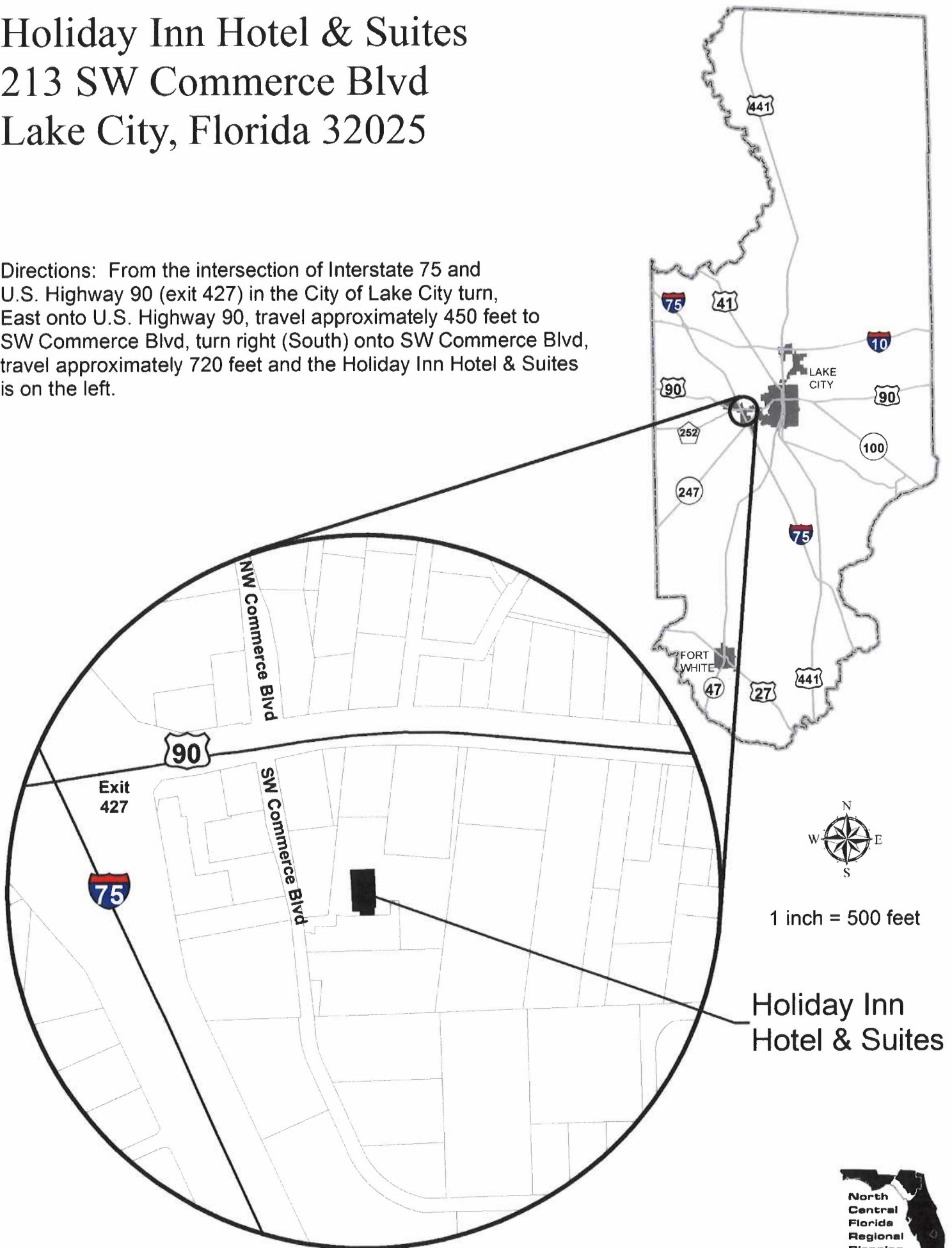

I. INVOCATION

In the absence of the Chair and Vice-Chair, Immediate Past Chair Fletcher Hope noting a quorum being present called the meeting to order at 7:02 p.m.

ACTION: Commissioner Demps made the motion, with a second by Mayor Louie Davis, to elect Immediate Past Chair Fletcher Hope as Acting Chair to preside at the meeting. The motion carried unanimously.

Commissioner Anthony Adams gave the invocation.

II. PLEDGE OF ALLEGIANCE

The Council and guests pledged allegiance to the flag of the United States of America.

III. INTRODUCTIONS

Acting Chair Hope welcomed Diana Davis, Executive Director, Alachua County League of Cities and wife of Council Member Louie Davis; and Stew Lilker, Columbia County Observer. Also, in attendance at the meeting was Troy Roberts, Communications and Outreach Office Chief, Suwannee River Water Management District.

IV. APPROVAL OF CONSENT AGENDA

Acting Chair Hope asked that the consent agenda be approved.

ACTION: Mayor Louie Davis made the motion, with a second by Commissioner Wheeler, to approve the consent agenda. The motion carried unanimously.

VI. GUEST SPEAKER – Amy Brown, Deputy Executive Director

Scott Koons, Executive Director, introduced Amy Brown, Deputy Executive Director, Suwannee River Water Management District. Ms. Brown made a presentation concerning drought conditions in the north central Florida region. Acting Chair Hope thanked her for her presentation.

VII. CHAIR REPORT

A. New Member

Acting Chair Hope reported that Commissioner Johnny Hiers, Levy County, recently became a member of the Council.

B. Resolutions of Appreciation

ACTION: Commissioner Demps made the motion, with a second by Commissioner Townsend, to authorize the Chair to sign a Resolution of Appreciation for former Council member Ken Cornell from Alachua County. The motion carried unanimously.

2. Desiree Mills, Levy County

ACTION: Mayor Louie Davis made the motion, with a second by Commissioner Townsend, to authorize the Chair to sign a Resolution of Appreciation for former Council member Desiree Mills from Levy County. The motion carried unanimously.

C. Transportation Disadvantaged Resolutions of Appreciation

1. Nick Hauzer

ACTION: Mayor Louie Davis made the motion, with a second by Commissioner Howell, to authorize the Chair to sign a Transportation Disadvantaged Program Resolution of Appreciation for Nick Hauzer the former alternate Florida Department of Elder Affairs Representative on the Alachua County Transportation Disadvantaged Coordinating Board. The motion carried unanimously.

2. John Wisker

ACTION: Commissioner Wheeler made the motion, with a second by Vice-Mayor Bouie Hutchinson, to authorize the Chair to sign a Transportation Disadvantaged Program Resolution of Appreciation for John Wisker, the former voting Florida Department of Children and Families Representative on the Bradford County, Dixie County, Gilchrist County and Levy County Transportation Disadvantaged Coordinating Boards. The motion carried unanimously.

D. Committee Appointments

ACTION: Commissioner Demps made the motion, with a second by Commissioner Howell, to ratify the appointment by the Chair of Commissioner Judy Townsend as Chair of the Clearinghouse Committee; Commissioner Don Hale and Commissioner Marihelen Wheeler to the Clearinghouse Committee; Vice-Mayor Patricia Bouie Hutchinson as Chair of the Finance Committee; Councilwoman Jhelecia Hawkins as the Chair of the Program Committee; Commissioner Johnny Hiers to the Program Committee; and Commissioner Marihelen Wheeler to the Regional Planning Committee. The motion carried unanimously.

VIII. COMMITTEE REPORTS

A. Executive Committee

1. Employee Health Insurance Proposal

Mr. Koons stated that UnitedHealthcare has offered to continue health insurance coverage for the Council with an increase in premiums for the coming year beginning April 1, 2026. He noted that the total change in the cost to the Council for the coming year would be \$8,124 or a 16.1 percent increase. Mr. Koons reported that the resulting total monthly cost to the Council would be \$4,882.

Mr. Koons reported that staff secured alternative proposals for health insurance from UnitedHealthcare for consideration by the Council. He noted that the alternative proposals include changes to benefits for employees. Mr. Koons stated that staff recommends that the Council approve the renewal proposal from UnitedHealthcare for Plan EP-9T/RX/L28S for health insurance for the year beginning April 1, 2026.

ACTION: Mayor Louie Davis made the motion, with a second by Commissioner Demps to select UnitedHealthcare renewal plan EP-9T/RX/L28S for employee health insurance for the year beginning April 1, 2026. The motion carried unanimously.

2. Land, Office and Warehouse

Mr. Koons stated that a commercial real estate broker has contacted Council staff indicating that potential buyers may be interested in purchasing the land, warehouse and office building owned by the Council. He recommended that the Council authorize the Executive Director to have an appraisal of the land, warehouse and office building completed by a licensed appraiser.

ACTION: Vice-Mayor Landry made the motion, with a second by Mayor Louie Davis, to authorize the Executive Director to have an appraisal of the land, warehouse and office building completed by a licensed appraiser. The motion carried unanimously.

3. Council Legal Services

Mr. Koons reported that Council Attorney Jonathan Wershow has resigned effective March 31, 2026. He noted that Mr. Wershow has served as Council Attorney for the past 44 years. He stated that, prior to serving as Council Attorney, Mr. Wershow was member of the Council from Alachua County from 1975 to 1982 and served as Chair of the Council in 1976-77 and 1977-78. Mr. Koons recommended that the Council authorize the Executive Director to contact attorneys to obtain proposed letters of engagement for legal services for review, selection and approval by the Council.

ACTION: Commissioner Wheeler made the motion, with a second by Mayor Louie Davis, to authorize the Executive Director to contact attorneys to obtain proposed letters of engagement for legal services for review, selection and approval by the Council. The motion carried unanimously.

B. Clearinghouse Committee - Committee Level Comprehensive Plan Review Items

Commissioner Judy Townsend, Acting Chair of the Clearinghouse Committee, reported that the Clearinghouse Committee met in person and virtually via communications media technology earlier in the evening and reviewed the following local government comprehensive plan amendments which were included on the Council agenda for consideration.

- #18 - City of Jasper Comprehensive Plan Adopted Amendment (FC No. 25-1ESR)
- #19 - City of Alachua Comprehensive Plan Adopted Amendment (FC No. 25-1ESR)

Commissioner Townsend stated with regards to these items, the Committee found that the local government comprehensive plans, as amended, were not anticipated to result in significant adverse impacts to regional facilities, Natural Resources of Regional Significance or adjacent local governments. She stated that the Committee recommends forwarding these findings to the respective local governments and the Florida Department of Commerce.

ACTION: Commissioner Townsend made the motion, with a second by Commissioner Adams, to approve the Clearinghouse Committee recommendations concerning Item - #18 City of Jasper Comprehensive Plan Adopted Amendment (FC No. 25-1ESR); and Item - #19 City of Alachua Comprehensive Plan Adopted Amendment (FC No. 25-1ESR). The motion carried unanimously.

IX. EX-OFFICIO MEMBER REPORTS -

David Tyler, Rural Transportation Planning Manager, Florida Department of Transportation District 2, reported that District 2 conducted Northeast Florida Construction Career Days 2026 on February 24-26, 2026 at the Jacksonville Equestrian Center in Jacksonville. He also reported that District 2 will hold Roads to the Future Career Day for professionals at the University of North Florida on April 8, 2026 at 11:00 a.m. in Jacksonville.

Austin Burgess, Senior Biologist, Florida Fish and Wildlife Conservation Commission, stated that the Commission is currently removing storm debris from the Jena Unit of the Big Bend Wildlife Management Area in Dixie County.

X. PUBLIC COMMENTS -

Layne Schultetus discussed the Water First North Florida Project to discharge treated wastewater from the Jacksonville Electric Authority via a pipeline into the Floridan Aquifer in the Lower Santa Fe River and Ichetucknee River Basin.

XI. EXECUTIVE DIRECTOR REPORT

A. Florida Regional Councils Association Monthly Activity Report

Mr. Koons reported that the Florida Regional Councils Association is the statewide organization of the ten regional planning councils. He stated that the Association strengthens Florida's regional planning councils, partners with government and the business community to enhance regional economic prosperity and improves the consistency and quality of regional planning councils programs to ensure they add value to state, regional and local initiatives. Mr. Koons also stated that the Association strives to accomplish these goals by carrying out the activities listed in the January 2026 activity report included in the Council meeting packet. He reviewed the activities listed in the January 2026 report.

B. Florida Regional Councils Association Policy Board Meeting Report

Mr. Koons reported that the Former Chair Charles Chestnut IV and Former Chair Thomas Demps, and he attended the semi-annual meeting of the Florida Regional Councils Association Policy Board held in Tallahassee on January 30, 2026.

Mr. Koons reported the Policy Board heard presentations from Greg Vaday, Florida Economic Development Representative, United States Economic Development Administration; Huiwei Shen, Chief Planner, Florida Department of Transportation; and Eddy Bouza, Chief Resiliency Officer, Florida Department of Environmental Protection.

Mr. Koons also stated that the Policy Board heard reports on various projects of regional planning councils throughout the state and received the 2024-25 Florida Regional Councils Association Annual Report. He noted that the Policy Board heard a legislative report, adopted legislative priorities, accepted the Financial Audit for Fiscal Year 2024-25 and received a financial report.

C. 2024-25 Florida Regional Council Association Annual Report

Mr. Koons presented the 2024-25 Annual Report of the Florida Regional Councils Association that was included in the Council meeting packet. He stated the Florida Regional Councils Association is the statewide association of all ten regional councils in Florida. Mr. Koons noted it is governed by a Policy Board made up of three representatives (county, municipal, gubernatorial) from each Council who are in turn advised by the Executive Directors Advisory Committee comprised of all ten executive directors. He stated the following members of the Council currently serve on the Florida Regional Councils Association Policy Board: Former Chair Charles Chestnut IV, Former Chair Thomas Demps and Former Chair Janice Mortimer. Mr. Koons stated the activities of the Council are featured on pages 5, 7, 8, 11 and 16 of the annual report.

D. Florida Chamber Foundation Scorecard™

Mr. Koons reported that the Florida Chamber Foundation has developed the Florida Scorecard™ to provide Florida leaders the metrics needed to secure Florida's future. He stated that the Florida Chamber Foundation's objective to developing a 20-year, statewide strategic plan requires a commitment to measuring our current status and progress toward the stated goals of the Six Pillars 20-year Strategic Plan. Mr. Koons noted that the Scorecard reports metrics for each of the following Six Pillars: Talent and Supply Education, Innovation and Economic Development, Infrastructure and Growth Leadership, Business Climate and Competitiveness, Civic and Governance Systems, and Quality of Life and Quality Places. He reviewed the February 2026 Scorecard™ that was included in the Council meeting packet.

E. Legislative Report

Mr. Koons stated the 2026 Legislature Session convened on January 13, 2026 and is scheduled to adjourn on March 13, 2026. He reported that the legislative interim Committee schedule was, as follows:

Mr. Koons reported on bills of interest to Council members and local governments.

RECOMMENDATION:

Authorize the Executive Director to sign an amendment to the memorandum of agreement with Tampa Bay Regional Planning Council for an additional year as a user of the Regional Economic Modeling, Inc., for a fixed fee amount of \$5,530.50.

BACKGROUND:

In 2005, the Council entered into a memorandum of agreement with the Tampa Bay Regional Planning Council to be a user of the Regional Economic Modeling, Inc. economic impact model. The Tampa Bay Regional Planning Council is a licensed user of the model by Regional Economic Modeling, Inc. The Tampa Bay Regional Planning Council is authorized to issue user rights to other parties subject to collection of a fee to be paid to Regional Economic Modeling, Inc. At this time, Tampa Bay Regional Planning Council is proposing to extend the Council's existing memorandum of agreement for a one-year period for a fixed fee of \$5,530.50.

The Regional Economic Modeling, Inc. model is based upon an input-output engine and provides the Council, our local governments, economic development agencies and others with a dynamic tool for economic and demographic analysis and forecasting. It uses national data calibrated for the region, but also can accept local data sets to enhance its accuracy. This model can review system-wide effects over both short- and long-range time horizons, include economic and fiscal impact analyses, policy impact analyses and economic development/redevelopment analyses. The model can be configured to either address the entire region of any number of county-based subsets of the region, as well as including counties in adjacent regions.

Council staff has used this model to evaluate the impact of several projects throughout the region. Examples of projects include a hotel and a redevelopment project in the City of Gainesville, a recreational vehicle resort in the City of Hawthorne, a food processing plant in the City of Newberry, a computer technical support call center, manufacturing facilities and sports complex in Columbia County, a refrigerated container manufacturing plant in Madison County, a manufacturing facility and a sawmill plant in Suwannee County.

RECOMMENDATION:

Approve attached Resolution No. 2026-13 recommending the Florida Commission for the Transportation Disadvantaged designate the Suwannee Valley Transit Authority as the Community Transportation Coordinator for Columbia, Hamilton and Suwannee Counties.

BACKGROUND:

The Council is the Designated Official Planning Agency for the Transportation Disadvantaged Program in Columbia, Hamilton and Suwannee Counties. The Florida Commission for the Transportation Disadvantaged requires that the designated official planning agencies conduct the selection process and recommend a Community Transportation Coordinator at the end of each contract period.

The Suwannee Valley Transit Authority is the designated Community Transportation Coordinator for Columbia, Hamilton and Suwannee Counties. The Suwannee Valley Transit Authority's Memorandum of Agreement will expire June 30, 2026.

Section 287.057(3) (e) 12, Florida Statutes, allows for contractual services or commodities provided by governmental entities to not be subject to competitive solicitation requirements. Rule 41-2.010 (2) of the Florida Administrative Code allows the selection of Community Transportation Coordinators without competitive acquisition upon the recommendation of the Designated Official Planning Agency. Therefore, the Florida Commission for the Transportation Disadvantaged may designate a governmental entity, such as the Suwannee Valley Transit Authority as the Community Transportation Coordinator without using a competitive selection process.

The Suwannee Valley Transit Authority is willing to continue serving as the Community Transportation Coordinator for Columbia, Hamilton and Suwannee Counties. Please find attached a resolution adopted by the Suwannee Valley Transit Authority concerning designation as the Community Transportation Coordinator.

A RESOLUTION OF THE NORTH CENTRAL FLORIDA REGIONAL PLANNING COUNCIL RECOMMENDING THE FLORIDA COMMISSION FOR THE TRANSPORTATION DISADVANTAGED DESIGNATE SUWANNEE VALLEY TRANSIT AUTHORITY THE COMMUNITY TRANSPORTATION COORDINATOR FOR COLUMBIA, HAMILTON AND SUWANNEE COUNTIES

WHEREAS, the North Central Florida Regional Planning Council, serving as the Designated Official Planning Agency for the Transportation Disadvantaged Program in Columbia, Hamilton and Suwannee Counties, has the authority to recommend the designation of the Community Transportation Coordinator, as authorized by Section 427.015(2), Florida Statutes and Rule 41-2.010(6), Florida Administrative Code;

NOW THEREFORE, BE IT RESOLVED BY THE NORTH CENTRAL FLORIDA REGIONAL PLANNING COUNCIL:

1. That the North Central Florida Regional Planning Council has the authority to recommend the Suwannee Valley Transit Authority to be designated the Community Transportation Coordinator for Columbia, Hamilton and Suwannee Counties;
2. That the Suwannee Valley Transit Authority is willing to provide the services necessary to serve the transportation disadvantaged populations;
3. That the Suwannee Valley Transit Authority has the appropriate personnel, financial capacity, vehicle and equipment resources, experience and qualifications to serve the transportation disadvantaged populations;
4. That the Suwannee Valley Transit Authority has demonstrated the ability to coordinate a multitude of funding sources and service provisions;
5. That the Suwannee Valley Transit Authority has identified specific means by which it will comply with the provisions of the Americans with Disabilities Act and applicable local regulations governing handicapped accessibility requirements;
6. That the Suwannee Valley Transit Authority has demonstrated plans to provide the most cost effective and quality transportation services;
7. That the Suwannee Valley Transit Authority has demonstrated plans to coordinate with the public school system, private sector operators and other governmental agencies to maximize the effectiveness of the coordinated transportation system;
8. That the Suwannee Valley Transit Authority has demonstrated its plans to comply with federal, state and local safety requirements as specified in Section 341.0161, Florida Statutes; and
9. That the Suwannee Valley Transit Authority has demonstrated plans to comply with state, federal and local laws relating to substance abuse testing.

WHEREAS, the Suwannee Valley Transit Authority hereby authorizes the filing and execution of the Memorandum of Agreement by the Chair of the Suwannee Valley Transit Authority as the Registered Agent on behalf of the Suwannee Valley Transit Authority or the Vice-Chair in the Chair's absence with the Florida Commission for the Transportation Disadvantaged.


NOW, THEREFORE, BE IT RESOLVED BY THE SUWANNEE VALLEY TRANSIT AUTHORITY THAT;

SUBJECT: Water First North Florida Aquifer Recharge Project Resolution No. 2026-14

RECOMMENDATION

Adopt Resolution No. 2026-14 opposing the Water First North Florida Aquifer Recharge Project and recommend the implementation of the alternative water desalinization project, and send a copy of the adopted resolution to the Governor, the President of the Florida Senate, the Speaker of the Florida House of Representatives, the north central Florida Legislative Delegation, the Suwannee River Water Management District, the St. Johns River Water Management District and the Jacksonville Electric Authority.

BACKGROUND

The Suwannee River Water Management District and St. Johns River Water Management District have announced a regional initiative, the Water First North Florida Aquifer Recharge Project, designed to return more than 40 million gallons of water per day to the Floridan Aquifer system to maintain minimum flows and levels in the Lower Santa Fe River Basin and the Ichetucknee River Basin.

The Water First North Florida partnership proposes to take reclaimed wastewater and further purify it through a natural wetland filtration system to recharge into the aquifer. The proposed wetland filtration system would be located in Duval County. The filtrated wastewater would be transmitted via a pipeline to a recharge site located in either Baker County, Bradford County, Columbia County, Hamilton County or Union County in the north central Florida region.

Both Districts jointly approved the project after determining it was the most cost-effective and environmentally beneficial solution to meet area water needs. Staffs evaluated more than 100 potential projects.

The estimated cost of the project is \$1.0 billion. The Jacksonville Electric Authority has pledged \$400 million and the St. Johns River Water Management District has pledged \$150 million for the project. An alternative desalinization project is estimated to cost between \$2.0 billion and \$3.0 billion.

According to the Districts, the initiative will deliver multiple long-term water benefits to the region.

- Restoring flows and protecting the health of rivers and springs;
- Recharging the aquifer to ensure a sustainable water supply for residents and visitors;
- Supporting agriculture, small businesses, tourism and future growth;
- Restoring wetlands that support wildlife habitat and enhance recreation; and
- Providing the greatest environmental return at the lowest cost compared with other alternatives.

RESOLUTION NO. 2026-14

A RESOLUTION OF THE NORTH CENTRAL FLORIDA REGIONAL PLANNING COUNCIL OPPOSING THE WATER FIRST NORTH FLORIDA AQUIFER RECHARGE PROJECT AND RECOMMENDING THE IMPLEMENTATION OF THE ALTERNATIVE WATER DESALINIZATION PROJECT

WHEREAS, the Floridan Aquifer, Ichetucknee River, Santa Fe River and 116 freshwater springs are designated as Natural Resources of Regional Significance by the North Central Florida Regional Planning Council, hereinafter referred to as the Council, in the North Central Florida Strategic Regional Policy Plan; and

WHEREAS, the water quality of the freshwater springs, rivers and the Floridan Aquifer is critical to the economic vitality of eco-tourism, agriculture and recreation in the north central Florida region; and

WHEREAS, the lowering of the potentiometric surface of the Floridan Aquifer by water users located outside of the north central Florida region has contributed to lower flows and levels in the Lower Santa Fe River Basin and Ichetucknee River Basin; and

WHEREAS, the Council recognizes the importance of achieving minimum flows and levels in the Lower Santa Fe River Basin and Ichetucknee River Basin as necessary to protect north central Florida region natural resources and the Council's interest in maintaining a high quality of life for its citizens and enjoyment of the area for residents and visitors; and

WHEREAS, the State of Florida local water sources first policy suggests that water users located outside of the north central Florida region should develop alternative water supplies, such as desalination; and

WHEREAS, the Water First North Florida Aquifer Recharge Project would discharge 40 million gallons per day of treated wastewater from outside the north central Florida region into the Floridan Aquifer in either Baker County, Bradford County, Columbia County, Hamilton County or Union County in the north central Florida region.

NOW, THEREFORE, in consideration of the foregoing, BE IT RESOLVED by the North Central Florida Regional Planning Council that:

1. The Council opposes the Water First North Florida Aquifer Recharge Project.
2. The Council recommends the Florida Legislature, the Florida Department of Environmental Protection, the Suwannee River Water Management District and the St. Johns River Water Management District re-evaluate the alternative local water sources first desalination project for water users located outside of the north central Florida region as a means to contribute towards achieving minimum flows and levels in the Lower Santa Fe River Basin and Ichetucknee River Basin.

SUBJECT: Middle and Lower Suwannee River and Withlacoochee River Update

BACKGROUND:

Pursuant to a request by the Madison County Board of County Commissioners, the Council authorized the Executive Director to convene and facilitate a meeting with representatives from Dixie, Gilchrist, Hamilton, Lafayette, Levy, Madison and Suwannee Counties to develop a plan to promote our area and help restore the reputation of the Middle and Lower Suwannee River and Withlacoochee River as a result of raw sewage spills from the City of Valdosta, Georgia. On September 19, 2018, Council staff convened and facilitated a meeting of county commissioners, and county administrators, coordinators and managers at the Madison County Agricultural Extension office in Madison. Representatives from Columbia, Dixie, Hamilton, Lafayette, Levy and Madison Counties were in attendance at the meeting.

By consensus, the county commissioners present requested the Council to establish a task force comprised of a county commissioner from each of the following counties, Alachua, Bradford, Columbia, Dixie, Gilchrist, Hamilton, Lafayette, Levy, Madison, Suwannee and Union Counties, in the Suwannee River Basin, including the Santa Fe River Basin, to address the issues of raw sewage spills by the City of Valdosta, Georgia. The county commissioners present also requested that the Council authorize its Executive Director to provide administrative support to the Task Force and to develop, in conjunction with county administrators, coordinators and managers, a strategic action plan to address the issue of raw sewage spills by the City of Valdosta, Georgia.

Pursuant to the request, at the Council meeting on September 27, 2018, the Council established the Middle Lower Suwannee River and Withlacoochee River Task Force to be comprised of Alachua, Bradford, Columbia, Dixie, Gilchrist, Hamilton, Lafayette, Levy, Madison, Suwannee, Taylor and Union Counties.

UPDATE:

The River Task Force met virtually on March 18, 2026 and received a report on activities conducted during 2025 concerning the Task Force's purpose and discussed the Water First North Florida Aquifer Water Recharge Project. In addition, the Task Force unanimously adopted a resolution opposing the Water First North Florida Aquifer Water Recharge Project and recommending the implementation of the alternative desalinization project to contribute towards achieving minimum flows and levels in the Ichetucknee River Basin and Lower Santa Fe River Basin.

 SUBJECT: Florida Job Growth Grant Fund

On March 6, 2026, more than \$9.0 million was awarded through the Florida Job Growth Grant Fund for infrastructure improvements and to expand workforce education. Since 2019, the Florida Job Growth Grant Fund has awarded more than \$328 million and created more than 43,000 new jobs and more than 33,000 new workforce education opportunities.

The Florida Job Growth Grant Fund is an economic development program designed to promote public infrastructure and workforce training across the state. These awards build on Florida’s commitment to investing in infrastructure and workforce development opportunities that attract businesses and fuel local economies.

Public infrastructure projects can include transportation and utilities needed to support economic development. Workforce training projects will provide Floridians with transferable, sustainable workforce skills applicable to many employers.

A total of \$3,000,000 in funding was awarded to the following school district in the north central Florida region through the Florida Job Growth Fund program.

- **Bradford County School District (\$3,000,000)** to construct and develop a new certified driver license training facility offered through North Florida Technical College to mirror the certified driver license program currently offered at Camp Blanding. The Camp Blanding lease expired in June 2024, but remains in place while funding is being secured for the new facility. The newly proposed training facility will allow the existing certified driver license program to double student enrollment, with a new total of up to 60 students per year.
